# **Programs: Global Classrooms® DC**

Global Classrooms\* DC (GCDC) is the lead education program of the United Nations Association of the National Capital Area and is a part of the Global Classrooms\* initiative of the United Nations Association of the USA to bring Model United Nations (Model UN) to students who would not otherwise have such opportunities.

GCDC has grown significantly in the 10 years since it was formed, expanding from an initial 16 schools in the 2003-2004 school year to 83 school groups in 2011-2012. Fifty participating DCPS schools were at the elementary and middle school levels, representing the largest increase in teacher and administrator interest and youth participation in GCDC history. More than 2800

students were touched by GCDC curriculum or events this year, with more than 2500 from D.C. Public Schools. About 900 of these students participated in special hands-on events such as GCDC's full-day youth conferences on global issues at the State Department and the Pan American Health Organization or through the school-responsive programming Collective Visioning and Courage at Jefferson Academy and Clean Water Access and Advocacy at H.D. Woodson Senior High School.

GCDC continued its partnership with the DCPS Embassy Adoption Program and Washington Performing Arts Society which helped GCDC connect more D.C. young folks with global education opportunities than ever before. The Pulitzer Center on Crisis Reporting

partnership brought engaging speakers and first-rate images to three major youth events, connecting GCDC students to photography and writing from the field to build understanding on our four Topics of Focus (see box).

The GCDC Youth Team of middle and high school interns has been busier than ever, actively supporting curriculum design, event logistics, and communications. At the same time, Youth Team members also have been published on Huffington Post, garnered major college scholarships, tweeted about topically relevant resources, and served as Model UN committee staff! The Youth Team also publishes the GCDC Advocate newsletter, a great monthly curriculum supplement that links to online resources and local events.

Model UN Trainer volunteers from The George Washington University staffed activities and regularly visited six participating schools. Our volunteer program for adult professionals welcomed more than 100 volunteers to support relevant and exciting learning for area students.

Our participating teachers and facilitators work to bring the best active and inspirational learning opportunities to their students. Their commitment spans the academic year, as they incorporate GCDC curriculum and activities into their classrooms and after-school or lunch clubs. Many teachers find that after GCDC students become more likely to chase them down in the hallway to talk about current events and global issues!

#### GCDC Spring Model UN Conference Highlights

May 1, 2012 at the U.S. Department of State and Pan American Health Organization

- 33 Schools participated: 17 high schools and 16 middle and elementary schools
- Over 600 students registered, including two delegations from Ghana and Nigeria
- Keynote address by Ronan Farrow, Special Adviser to the Secretary of State on Global Youth Issues
- Nine Youth Committees convened, discussed, debated, and passed resolutions on the Topics of Focus (see box)
- Secretary-General Samantha Brew from McKinley Technology High School emceed Opening and Closing Ceremonies in the State Department Dean Acheson Auditorium
- The Pulitzer Center on Crisis Reporting and the UN Information Center supported youth and teachers with special programming on committee topics
- The Washington Performing Arts Society helped bring DCPS Embassy Adoption Program teachers and 6<sup>th</sup> grade students to the event and announced the winners of their country poster contest
- More than 80 adults volunteered on conference day to help with registration, lunch, committee support, and research library stations





December 15 at 9:30 am marked the beginning of an educational and cooperative day where students exercised public speaking and problem solving skills. "I am young, I am powerful, right now!" was echoed throughout the Pan American Health Organization by numerous high school students from the Washington D.C. area. This quote from the opening ceremony, given by UNA-NCA Director of Global Education, Jill Ruchala, provided the incentive for students representing many international stakeholders' viewpoints on the global issue of child soldiers.

The opening ceremony also included Emily Heron, a George Washington University graduate student, who provided an overview of the issue and photographer Andre Lambertson who recalled his experiences of befriending former child soldiers in Liberia.

Students from five secondary schools (Ballou Senior High School, Dunbar High School, The Lab School of Washington, McKinley Technology High School, and Winston Churchill High School) said that the UN simulation was one of the best parts of the experience. The in-depth debate on child soldiers gave students a chance to distinguish between governmental policy decisions, national civilian debates, and their personal stance on the matter.

The facts provided by the guest speakers at the ceremony and the information attained from the GCDC curriculum aided students in an active moderated caucus. The conference on child soldiers not only provided information on the issue, but also exercised students' global awareness, communication, and problem solving skills.

Samantha Brew from McKinley Technology High School participated in GCDC for three years and served as Secretary-General at UNA-NCA's 2012 Spring Model UN Conference at the State Department. She has also won one of nine prestigious Trachtenberg Scholarship Awards to attend The George Washington University! It is a full four-year scholarship, including tuition, room, board, books, and more (worth approximately \$250,000).

Samantha has been participating in GCDC Model UN since her sophomore year when she represented Turkey. Her experience shaped her career plan to become a human rights prosecutor: "I want to be able to represent those people who don't have any representation. I found out that 525,000 people were trafficked through Turkey every year – it blew my mind. From that moment on, I knew I had to do something about it ... [Model UN] helps develop awesome com-

munication skills and helps us learn how to network and negotiate with our peers ... It helped me connect and get to know people."

Samantha credits GCDC with guiding her toward international affairs and international law, as well as improving her public speaking. She and her family thank the GCDC team and everyone at UNA-NCA, with an extra-special thank you to GCDC team member Gena Magill who coordinates our GCDC youth team, for her continued mentoring support during the application process. Samantha is just one of the thousands of students who benefit from the GCDC program. She hopes that others will join Model United Nations and contribute to the efforts of Global Classrooms DC: "Getting this opportunity in high school is amazing; you get to put your ideas out there, it's a very unique experience."

2011

October: The UNA-NCA Young Professionals hosted a successful International Career Dinner series during UN Month 2011 where UNA-NCA YP was able to recruit the largest number of new members registering at a UNA-NCA event in recent history. Attendees began the evening at a networking reception followed by intimate, themed dinners. Dinner topics included: women in international development, international organizations, peace and security, international economic development, international advocacy, and international non-profits.

Young professionals from various backgrounds, career fields, and educations took part in this participatory event where they not only met their distinguished dinner panels, but they were provided an opportunity to network with other young professionals who shared similar interests.

In addition to the Career Dinners, several UNA-NCA YP committees planned events for UN Month: The UNA-NCA YP Middle East Committee hosted an evening event entitled Women in the MENA Region: Socio-Economic Issues in the Current Climate. The UNA-NCA YP International Law Committee, in collaboration with the general UNA-NCA International Law Committee and the American Bar Association Section of International Law, hosted a panel discussion entitled Legal Issues Facing the United Nations - Reflections from Three Years as Legal Counsel with UN Under-Secretary General for Legal Affairs, Patricia O'Brien.

May: The Young Professionals arranged another successful International Career Dinner series in May 2012. More than 50 guests convened at a Capitol Hill reception where Rodney Bent, Director of the United Nations Information Center in D.C., delivered a keynote address on his international experience in the public and private sectors. Dinners were then hosted at private homes throughout D.C., with topics focused on careers in international peace building, international organizations, and women in international affairs.

UNA-NCA YP also hosted a Networking Happy Hour at Café Citron in May, giving young professionals the opportunity to mingle with each other and learn about UNA-NCA activities. A portion of proceeds from Café Citron's signature "Peace Keeper" drink was donated to UNA-NCA.

June: UNA-NCA YP is cosponsoring a happy hour with UNA-USA that is part of the national office members annual meeting.

UNA-NCA YP is looking forward to hosting more happy hours and re-launching its bi-monthly, brown bag Lunch & Learn series. In the upcoming year, UNA-NCA YP will work closely with college and university groups and will work with UNA university students to further university outreach.

The United Nations Association of the National Capital Area commemorated Human Rights Day with its annual Human Rights Luncheon on Capitol Hill. The event honored Professor Thomas Buergenthal with the UNA-NCA Louis B. Sohn Human Rights Award and Zainab Salbi with the UNA-NCA Perdita Huston Human Rights Award for their extraordinary commitment to human rights. In addition to the main awardees, five members of the D.C. community were recognized with UNA-NCA Community Human Rights Awards.

Over 180 members and supporters of UNA-NCA gathered in the Cannon House Office Building, Caucus Room on December 8. The luncheon commenced with welcome remarks by UNA-NCA President Karen Mulhauser, who introduced the program participants and recognized the recent passing of Board Member and Human Rights Luncheon Chair, Richard Griffis (see tribute).

Steve Knapp, President of The George Washington University, introduced the Louis B. Sohn Human Rights Award honoree, Thomas Buergenthal. Thomas Buergenthal is a Professor of Law at George Washington Law and has a long career as a judge at both the International Court of Justice (ICJ) and the Inter-American Court of Human Rights, where he also served as president. Professor Buergenthal expressed his admiration for his mentor and friend, Louis B. Sohn, and discussed how this student-teacher relationship inspired him to dedicate his career to international law and human rights. Buergenthal's address left the audience with the opportunity to reflect on the importance of recognizing those who inspire them to work toward justice.

Cindy Dyer, Human Rights Director at Vital Voices Global Partnership, introduced Zainab Salbi for the Perdita Huston Human Rights Award for her commitment to women's rights. Zainab Salbi is the founder and former CEO of Women for Women International and has dedicated her life to working with women of war-torn zones. Ms. Salbi gave an inspiring speech noting her belief that to be an effective advocate for human rights, it is important to have an emotional connection with those whose human rights are compromised.

Our Community Human Rights Awards are given annually to individuals who are nominated by the D.C. community for their outstanding commitment to human rights. This year's awardees were Mary C. Cogar of Advocates for Survivors of Torture and Trauma, Billie Day of League of Women Voters for District of Columbia, James N. Ellenberger of AFL-CIO Retirees Association, Ashley McSwan of Our Place D.C., Aileen Pisciota of the American Bar Association Section of International Law, and Annette Lantos of Citizens for Global Solutions. Annette's late husband, former Congressman Tom Lantos, received the Louis B. Sohn Human Rights Award in 2001. UNA-NCA Executive Director Paula Boland and former UNA-NCA Human Rights Luncheon Chair John Salzberg presented these awards to each honoree.

In closing, UNA-NCA Executive Director Paula Boland took a moment to recognize the importance of human rights and having such events as this luncheon. She emphasized the necessity to recognize the outstanding and inspiring work of others.




#### Richard Griffis December 6, 2011

In 2011 a dear friend, extraordinary human being, and human rights leader died of a massive stroke. Richard Griffis will be missed by all who knew him.

Richard's passion and dedication to working for human and civil rights for all people will be especially missed at the United Nations Association of the National Capital Area where he was a longtime board member, served as Vice President for Finance and Programs, and was the Chair of the Human Rights Committee. Richard was the force behind the concept and organization of the Annual Human Rights Luncheon.

Richard was a retired minister in the United Church of Christ. He and his wife Anne have been active in the UNA family, first in the Connecticut Chapter, then with UNA-NCA after Richard and Anne moved to Washington, D.C. in 2003. Richard and Anne always offered their genuine caring and encouragement to others. They have been among the first to volunteer to lead causes and address specific human rights concerns. Richard always found ways to involve young leaders and engage them in ways that allowed them to both demonstrate their strengths and grow even stronger.

#### Dr. Alan Francis Geyer November 28, 2011

Dr. Alan Francis Geyer died at age 80 on November 28, 2011. Among his many capacities, he served as Director of International Relations for the United Church of Christ, based at the Church Center for the United Nations (1965-68). He was Dag Hammarskjöld Professor of Peace Studies and Political Science at Colgate University in New York and founding director of its Peace Studies department (1972-77). He was chair of the U.S. Observers at the 1975 and 1980 Non-Proliferation Treaty Review conferences in Geneva and participated in the UN Special Sessions on Disarmament. He was active in the UNA-NCA his whole adult life, leading its Advisory Council and facilitating collaborations with the National Cathedral in peace and justice programs. Dr. Geyer will be missed by many in the UNA family.

#### Frank Kameny October 11, 2011

UNA-NCA mourns the loss of Frank Kameny, a D.C. activist for the LGBT movement. He was a winner of the third annual Cornelius R. Alexander Jr. Humanitarian Award in 2010 given by D.C.'s Office of Human Rights and D.C. Commission on Human Rights on the ocassion of the 2010 UNA-NCA Annual Human Rights Luncheon. Kameny was a pioneer for gay rights, a D.C. hero who even has a street named for him, and a great humanitarian. He will be greatly missed and always remembered.

#### **Sustainable Development Committee**

The Sustainable Development Committee (SDC) promotes awareness, understanding, and support of issues and actions related to climate change and the Millennium Development Goals (MDGs) including: ending poverty and hunger, universal education, gender equality, child health, maternal health, combating HIV/AIDS, and environmental sustainability. The SDC restructured in 2011 and the new co-chairs set a priority to build a long-term sustainable development programming strategy and increase professional networking within the community.

#### 2011

September: The SDC hosted a presentation and book signing with author John N. Morfaw. Mr. Morfaw spoke about the key points in his new book Project Sustainability: A Comprehensive Guide to Sustaining Projects, Systems, and Organizations in a Competitive Marketplace.

October: The SDC organized the UN month event, International Cooperation and Sustainable Resources in Today's World at the George Washington University.

The also SDC hosted a joint networking mixer with the D.C. Net Impact Professional Chapter, a professional association focusing on sustainable business practices.

November: The SDC launched its official LinkedIn page and began sending emails to interested participants on global sustainable development.

The PSC also examines U.S. policy toward the UN's initiatives ranging from field support, police missions, mine action, environment, and sustainability.


#### 2011

This year proved to be the strongest year for the PSC in UNA-NCA. The PSC hosted more events than ever before and gained more sponsorships.

May: In honor of the International Day of Peace-keepers, Ambassador Lincoln Bloomfield, Jr, Stimson L. Center Chair, discussed with Alain Le Roy, United Nations Under-Secretary-General for Peacekeeping, the role of peacekeeping operations in the world today, as well as other topics related to international peace and security. The event was co-hosted with the Better World Campaign and the Stimson L. Center. Ambassador Le Roy also conducted meetings at the Department of State, and the National Security Council as well as Congressional meetings on Capitol Hill. The day concluded with a reception on Capitol Hill where several countries were acknowledged for their support to peacekeeping missions.

October: The PSC organized a panel discussion titled The UN: Working for Women on the 11<sup>th</sup> anniversary of UN Resolution 1325 on Women, Peace, and Security.

October: The Peace, Security, and Roma in Europe event raised awareness for the Roma's ongoing struggle for equal rights and opportunities. The Roma are often called Gypsies. The event was cosponsored by the Atlantic Council.

#### 2012

#### **Advocacy Committee**

The goal of the Advocacy Committee (AC) is to fulfill UNA-USA's advocacy mission by focusing on congressional office visits on Capitol Hill and sustaining relationships through follow-up meetings to increase effectiveness. AC issues prioritize congressional funding for UN peacekeeping, UN dues, and U.S. foreign assistance related to the UN's Millennium Development Goals.

#### 2011

October: The AC met with Congressional staff and presented an independent, non-partisan survey commissioned by the Better World Campaign which indicates that 86% of voters support a strong UN-U.S. relationship. The AC summarized the importance of paying dues on time and in full to improve U.S. influence across the globe and to support the democratic principles upon which the U.S. and the UN were founded. The UN's role in international security and the cost savings of using UN peacekeepers rather than U.S. troops was highlighted.

#### 2012

April: A successful advocacy training with Maryland members took place at the Potomac Community Center.

The AC plans to offer training to Maryland and Virginia UNA-NCA members through Make a Difference: Advocacy 101 training events. The AC will reach out to members via social media, happy hours, and other events. The AC will focus on informing constituents of in-district meetings and developing strategies to engage members of Congress who are less likely to support UN- U.S. relations.

#### **Africa Affairs Committee**

The Africa Affairs Committee (AAC) strives to educate the members of the Association as well as the general community about issues pertinent to the African continent by addressing the educational, cultural, political, and social issues affecting these countries. The aims and objectives are to support the principles of the UN through a series of lectures, meetings, and social activities while bringing together a community of Africans and non-Africans interested in working on issues related to Africa.

#### 2012

February: In honor of Black History Month, the AAC gave awards of recognition to Barbra Lee and Rosa Whittaker at the event titled African American Women in Global Affairs. Africacare was a cosposnor.

June: The event The Hopeful Continent: Can Sustained GDP Growth in Africa Lead to a New Future? was cosponsored by the Africa Society.

The AAC is planning events on South Sudan and a Nollywood night.

#### **Human Rights Committee**

The Human Rights Committee (HRC) promotes human rights as defined by the UN Universal Declaration of Human Rights, including specific recent concerns for the rights of women and children, international labor rights, and the issue of congressional voting rights in the District of Columbia. HRC is responsible for soliciting nominations and recommending a nominee for the Louis B. Sohn Human Rights Award given annually at the Human Rights Day Luncheon on Capitol Hill.

2011

The HRC and USAID's Maternal and Child Health Integrated Program (MCHIP) hosted an event Commemorating 30 Years of HIV/AIDS and the Elimination of Mother-To-Child Transmission.

The HRC and MCHIP also presented a panel discussion at the UN Foundation on Oil of the 21st Century: Water Scarcity and Global Impact.

December: Unfortunately, the HRC lost its Chair, Richard Griffis, in December (see tribute). Richard Griffis will be missed by all who knew him.

2012

The HRC is remaining active while searching for a new chair. The HRC plans to host events around the topics of refugees, women's rights, access to clean water, and workers rights. The preparations for the 2012 Human Rights Day Luncheon are already underway.

#### **International Law Committee**

The International Law committee (ILC) fosters dialogue concerning the UN and its role in international law issues. The ILC covers a wide range of topics related to the UN and International Law, including the International Criminal Court (ICC) and U.S. policies, and seeks to advance and promote the work of the UN via events and other awareness-raising activities.

2011

A wide range of opportunities for U.S. lawyers to engage in careers in international law and international commercial practice were discussed at Careers in International Law.

#### **Communications**

UNA-NCA leaders and the Communications Committee have worked together to focus our messaging platform and branding. Once again, Ogilvy PR Worldwide has been integral in this progress. As a result of the UNA-USA and UN Foundation alliance, all UNA chapters have been given striking new membership brochures. UNA-USA is in the process of a web redesign that extends to the creation of web templates to be used by all the chapters.

At communication strategy meetings in the spring, we began a communication outreach strategy for the GCDC Spring Model United Nations conference at the State Department. The campaign was extremely successful and helped GCDC receive media coverage from various media outlets for the first time.

Concomitant with the messaging progress, we have begun the formation of a new social media plan. We are building upon the social media outreach of last year and trying to further integrate with the ever growing and popular Facebook and Twitter social platforms. With this, UNA-NCA has taken the next step in expanding our public outreach and some committees have created web and LinkedIn pages. A survey to members has beeen sent out recenly to better utilize our social media tools.

#### Membership

Last year proved to be a year of record-breaking membership growth for UNA-NCA positioning it again as the largest chapter of UNA-USA ... and we've broken several UNA-NCA membership recruitment records in the process. We established a new record of 119 for most members in a single month (UN Month in October), our fall Young Professionals Career Dinners signed up the most members for one event, and February saw the most members in one day. Despite this significant growth, retention continues to be a challenge and deserves priority attention.

We're also pleased to announce the commencement of our new Ambassador Program with its inaugural Ambassadors Roundtable training session. UNA-NCA Ambassadors serve as official representatives in an enhanced volunteer capacity to support the mission of the organization in their day-to-day lives. Ambassadors are specially skilled and committed message-bearers who are also responsible for attending UNA-NCA events as a resource for attendees on our organization, advocacy initiatives, and membership.



#### **Events:**

#### **United Nations Month**



UNA-NCA started years ago celebrating UN Day, which grew into a week packed with events, then the "Week" was expanded to 10 days. This year, the celebration was extended to a full month! The staff and planning team upped their efforts and UN Month had over 20 successful events on a range of UN related topics. From happy hours to career dinners to Kennedy Center performances to panel discussions on women, international voting rights or water resources – UN Month had it all!

UN month is a time to appreciate what the UN does as a global organization focused on protection, aid, and preserving culture and history, while also realizing the role the United States plays in this critical organization. Many UNANCA members did advocacy work on Capitol Hill during UN Month to help support U.S. funding for the UN. UNA-NCA was happy to welcome over 100 new members during UN Month, which is a record for new membership.

The following are some brief summaries of two events about which UNA-NCA members were particularly excited:

#### Libya in Transition

The event was co-sponsored by the UNA-NCA Human Rights Committee and the U.S. Institute of Peace. The four panelists discussed the current situation in Libya and the implications of the approval of UN Resolution 1973. They covered the decision of the UN Security Council to intervene militarily and the weaknesses and challenges the National Transitional Council might face. The panelists acknowledge that Libya's strength is its civil society and despite the need of the international community for mechanical support, the panelists agreed that change and success will occur as long as it comes from within Libya and its people.

#### Legal Issues Facing the United Nations Reflections from Three Years as Legal Counsel

The current UN Under-Secretary-General for Legal Affairs, Ms. Patricia O'Brien, shared her perspectives on the UN's advancement in international law and jurisprudence. Ms. O'Brien focused her remarks on the key role of the UN Legal Counsel to support the UN's mission for strengthening the rule of law, the pursuit of justice, and the determination to end impunity for genocide, crimes against humanity, war crimes, and other serious violations of international humanitarian and human rights law. Specifically, Ms. O'Brien underscored the importance of the principle of the rule of law, embedded in the UN Charter, as "without it, the lines between justice and tyranny can too easily blur or disappear altogether." Ms. O'Brien also spoke in detail about the role of her office in supporting international efforts to combat impunity and developing a culture of accountability for international crimes, especially through the International Criminal Court (ICC). Indeed, she noted that the ICC is "the centerpiece of our system of international criminal justice."





#### **UNA-NCA Endowment and Investment Funds**

The value of UNA-NCA investments recovered from the recession of 2007- 2008 but did experience a downward trend again during end of 2011. The following table gives the value of the investments for each of the three years 2009 -2011, as of December 31, 2011.

Fund A (Florence Pepper Schott Fund), Fund C (Perdita Huston Fund), and Fund D (Andrew E. Rice Fund) are invested in a diversified portfolio of domestic and some foreign stocks and bonds, chosen for both income and capital appreciation. Fund B (Evelyn Falkowski Fund) is invested in high-yielding securities intended to fund as much as possible of the rent of the UNA-NCA offices. Chosen to provide income, this fund cannot be expected to show significant appreciation. Nonetheless, the overall performance of all four funds in 2011 was gratifying.

Disbursements from these funds in 2011 to help meet operating costs, office rent, and our Global Classroom program, were \$50,051 (which includes the 5% annual support from Fund A.)
