A Letter From Our LEADERSHIP



As June begins, it is hard to recall clearly this time a year ago – a time before any hint of the coronavirus pandemic or its many impacts upon our families and communities. Amidst these challenges, UNA-NCA has adapted swiftly – transitioning its programming to virtual forums that have allowed us to continue serving our members while prioritizing the safety of our community.

As we live through this moment, we see that all of us are closely linked and affected by global forces transcending all national and international boundaries. Despite our borders, there can be no doubt that our health, livelihoods, community structures, food, security, and rights are deeply intertwined. Witnessing the pandemic’s path through our societies also reveals America’s longstanding history with unequal treatment across races, classes, gender, ages, and geographies. This pandemic has underscored the critical need for robust US investment and leadership in the UN system, at the core of our mission.

UNA-NCA has continued to strengthen its advocacy outreach in partnership with the Better World Campaign and UNA chapters nationwide. Through training and digital outreach, our advocacy program has expanded its reach to our community and congressional representatives to gain their support for the US to fully meet its funding commitments to the UN.

Our flagship education program, Global Classrooms DC, successfully implemented its year round activities until schools had to close. It had since offered virtual sessions to students and educators, and strengthened partnerships. Our unique Graduate Fellows Program– comprised of 23 exceptional students from most of the area universities– quickly transitioned to a virtual format enabling a successful completion with terrific resource speakers and mentors. Our Young Professionals saw large turnouts at their Career Dinners Series last fall and was able to offer virtual mentoring and career discussion opportunities this spring. We celebrated “UN Day” this past October featuring keynote addresses by the Executive Director of the UN Environment Programme and the UN Assistant Secretary-General for Human Rights. This past December, our annual Human Rights Awards Reception recognized four outstanding leaders, both locally and globally.

Marking the occasion of the UN’s 75th anniversary, UNA-NCA recently completed a series of public consultations with a variety of stakeholders in order to collect recommendations on how the UN must evolve to meet today’s challenges. These recommendations will be submitted to the UN Secretary-General for review during the United Nations General Assembly in September 2020. UNA-NCA’s program committees remained active while a newly added series called “Coffee Chats” offered a forum for discussion of the UN’s Sustainable Development Goals, has received outstanding attendance from within and beyond our jurisdiction.

We applaud our staff, program assistants and volunteers who have planned and organized these programs throughout the year. Our partnerships with UN agencies, State Department and NGOs in our community have made it possible to achieve our programmatic goals and outreach in our community.

The UNA-NCA Bylaws were amended to reflect current and best practices, including new leadership roles. Our Nominating team did a fine job strengthening the diversity and skillsets on our Board, and UNA-NCA’s operations was strengthened by the fine work of our Development, Finance, Communications, and Membership Committees.

The contributions from the many volunteers, Board members, Advisory Council members, and supporting organizations listed in this annual report is both heartening and essential for the success of our organization. These include the generous charitable gifts by individuals, organizations, and family foundations. These gifts have enabled UNA-NCA to continue to thrive – allowing us to maintain a balanced budget, strengthened our operational reserves while building the long-term support necessary to keep our organization healthy for the years ahead.

We look forward to a strong year ahead and count on your continued support. Thank you!

Graduate FELLOWS Program

UNA-NCA's 2020 cohort of 23 Graduate Fellows were current graduate students from nine universities, examined various global issues from the perspective of the UN, participated in weekly conversations with UN thought leaders, and collaborated with leaders and volunteer mentors on their professional development. Over the course of 14 sessions, held on Friday of each week, Graduate Fellows studied such topics as reforming the UN system, financing the sustainable development goals, and meeting the challenge of climate. In addition to their readings and coursework, Fellows had the unique opportunity to engage in conversations alongside UN experts such as Robert Orr, Special Adviser on Climate Change to the UN Secretary-General, and UN Independent Expert on Sexual Orientation and Gender Identity Victor Madrigal-Borloz, as well as NGO and government officials like Anthony Pipa, Senior Fellow at the Brookings Institution and former chief strategy officer at the U.S. Agency for International Development and Micah Spangler, Director of Advocacy and Humanitarian Affairs at the Better World Campaign.



UNA - NCA ADVOCATES FOR A STRONG U.S.-UN PARTNERSHIP



UNA-NCA WORKS CLOSELY WITH CONGRESS

In December of 2019, UNA-NCA staff and members joined UNA-USA on Capitol Hill to **urge members of Congress to denounce U.S. withdrawal from the Paris Climate Agreement.** The team (*pictured left*) emphasized the vitality of global cooperation to achieve shared goals, citing

the impacts of climate change on recent catastrophic wildfires and hurricanes. Members will continue to engage their legislative representatives within Congress and respective state legislatures through virtual in-district meetings in June and July of 2020, **emphasizing the vitality of expanded cooperation with the World Health Organization (WHO)** and supplemental funds allocated towards the UN in the FY'20 budget. During the week of June 22, 2020, UNA-NCA will join advocates across all 50 states in participating in virtual meetings with members of Congress as part of UNA-USA's United Together campaign.

ADVOCACY IN ACTION

On April 7, 2020, UNA-NCA hosted a virtual Day of Action to commemorate World Health Day, preceded by a virtual Advocacy Training led by UNA-NCA and UNA-USA staff. The interactive training **briefed participants on best practices for digital advocacy,** specifically highlighting the importance of a strong "elevator pitch" and concise, accessible social media content.

UNA-NCA's Advocacy Team partnered with the Human Rights Committee to organize visits to key country embassies identified in DC in order to **brief and recommend that these embassies submit action proposals to their governments during the U.S. Universal Periodic Review (UPR).** These educational visits presented the opportunity to generate awareness surrounding the status of human rights in the National Capital Area, with specific attention to gender equality, affordable housing, and DC statehood.

COFFEE CHATS

UNA-NCA Coffee Chats are built on community, bringing together policy experts, corporate executives, community activists, faith leaders, student representatives, artists, storytellers, and everyone in between for hour-long facilitated discussions related to the 17 Global Goals for Sustainable Development (See right for the initial topics covered). Successfully launched in April of 2020, Coffee Chats have bridged the digital divide across UNA-NCA's membership - and connected with allies across the country. Coffee Chats average approximately **160 registrants** and **83 participants**; Our Coffee Chat on Business-NGO Partnerships with Google, Starbucks, UNFCU and more yielded over **196 registrants** and **93 participants**. Quickly emerging as a signature program, Coffee Chats presented a unique and diverse set of expertise in an accessible and dynamic format. Through a combination of our Coffee Chats, video highlight reels, and SDG Spotlight reports, UNA-NCA's Advocacy Team is reaching new audiences and mobilizing nuanced discussions surrounding action in support of the United Nations.

GLOBAL CLASSROOMS DC

WHAT IS GCDC? Founded in 2003, UNA-NCA's flagship program Global Classrooms DC (GCDC) teaches middle and high school students about our world, and inspires them to be engaged advocates. Our students achieve this goal through Model UN and experiential learning opportunities through partnerships with UN agencies and the U.S. Department of State. Despite the COVID-19 pandemic, GCDC reached 915 students across 44 groups during the 2019-2020 school year, 30% of whom attended Title 1 schools.

FALL MODEL UN TRAINING CONFERENCE


Students in GCDC's year-round program attended the event designed for students who have never done Model UN before. In November 2019, 166 student delegates debated solutions to the malnutrition crisis as WHO member states.

2019-2020 SCHOOL YEAR HIGHLIGHTS

GCDC continued partnerships with the International Labour Organization and the International Organization for Migration, and also worked with the UN Environment Programme for the first time. Despite our Spring Model UN Conference cancellation, we made significant curriculum updates based on educator feedback, and finished Unit 1 before May 2020. Lastly, after three years as director, Nicole Bohannon departed UNA-NCA for graduate school. Jaiya Lalla, previously the GCDC Deputy Manager, is now leading the program.

OUR PLANET. OUR FUTURE.

UNA-NCA Kicked off the 2019 UN Month Celebrations at the UN Foundation with another highly successful event organized by UNA-NCA, in collaboration with the UN Environment Programme. This program highlighted the work of the UN Environment Programme (UNEP) and its Executive Director, Inger Andersen.

The event succeeded in **connecting the global and local dimensions of the climate change** challenge by joining Ms. Andersen's remarks with a discussion including former Environmental Protection Agency Deputy Administrator Robert Perciasepe who currently serves as the President of the Center for Climate and Energy Solutions, and moderated by Ryan Hobert, Managing Director for Energy and Climate at the UN Foundation (*pictured below, along with UNA-NCA Executive Director Paula Boland and UNA-USA Executive Director Rachel Pittman*).



Paula Boland welcomed guests saying, "This UN Month, we found it critical to engage in a discussion about the global climate change challenge.

In her remarks, Andersen stated, "Climate change is eating into our well-being, economic development, peace and stability, and unfortunately unless we take action, it will only get worse." She continued, "The **UN has always been at the core of finding common grounds** and the platform where we develop collective action, whether on the Sustainable Development Goals or the Paris Agreement. The environment challenge is one that travels across boundaries, and in a sense, binds nations together. The environment is the platform that can enable multilateral action."

At the end of the event, a strong call-to-action was made by Andersen, Perciasepe, and Hobert directly to the participants of the event, emphasizing that this call should be one that everyone actively chooses to answer.

THE UN AND HUMAN RIGHTS IN 2019

UNA-NCA's second UN Month Celebration, hosted on Capitol Hill, featured UN Assistant Secretary-General for Human Rights Andrew Gilmour and former Ambassadors Sarah Mendelson and Keith Harper (*pictured below, with Gilmour at the podium*) for a discussion focused on the many human rights challenges facing the UN in 2019. Under-Secretary Gilmour placed current problems in a historical context, and cited differences of perspective among UN Security Council members, including the Security Council's Permanent Five Members, on the extent to which the Council should engage on human rights issues associated with international security problems.



During the discussion, the speakers stressed several areas **including the significance of protecting current human rights standards and institutions** against backlash attacks from authoritarians; calling for the U.S. to re-engage as a member of the Human Rights Council; and the complicated position of ethnic conflicts in regards to human rights. Considering these situations as ones which concern human rights may expedite their being addressed, before they can evolve into even more difficult issues of international peace and security.

In a show of hope, it was reported that **the UN's human rights agenda has evolved considerably** over the decades. Previously being determined solely from the perspective of leading world powers, lately the agenda has become widely global, yet inclusive.



UNIVERSAL PERIODIC REVIEW OF THE UNITED STATES OF AMERICA

Over the course of 2019 & 2020, the Human Rights Committee and Cities for CEDAW Committee led and participated in a variety of activities related to the United States' Universal Periodic Review. The Universal Periodic Review (UPR) is a **process of the United Nations Human Rights Council that examines the human**



rights performance of each Member State. Local communities and civil

society organizations had the opportunity to contribute reports to inform the United States' review through a process called shadow reporting. In October 2019, UNA-NCA's committees submitted two reports, the first entitled "The Situation of Human Rights in the District of Columbia as Concerns the Lack of Statehood and Voting Rights as well as Entrenched Inequality and the Lack of Affordable Housing" in partnership with the DC Human Rights City Alliance (DCHRCA) and the George Washington Law School International Human Rights Clinic. The second report was

conducted in partnership with the Gender Justice Project at the University of the District of Columbia David A. Clarke School of Law entitled "Gender Equity in Our Nation's Capital"

In June, UNA-NCA and the DCHRCA conducted a public survey to ask DC residents, **"What are the three most important human rights issues for DC?"** Following the survey's identification of the human rights issues to be spotlighted in the report, UNA-NCA and the DC Human Rights City Alliance hosted three community roundtables over the summer of 2019, inviting experts and the public to learn about and discuss each of the topics.

Following submission of the report, the Committee, DCHRCA, and GW Clinic conducted visits to embassies in DC to educate staff on the human rights issues covered in the report.

Young Professionals' Fall Career Dinner

UNA-NCA and its Young Professionals Program hosted the 2019 Fall Career Dinners on Saturday, November 2nd with **keynote remarks by Loyce Pace, President & Executive Director of the Global Health Council (pictured above in red jacket)** and UNA-NCA Director at large. This semi-annual event brought young professionals together with experts from their chosen fields to **discuss career paths, share personal stories,** and network. The series featured intimate dinners focused on Careers in the United Nations, Careers in International Law, Careers in Human Rights and Journalism, Careers in Climate and Gender, Careers in International Education, and Careers in Global Health.

Young Professionals' Virtual Career Sessions

In the Spring of 2020, the Young Professionals launched Virtual Office Hours to provide mentoring opportunities, alongside a Virtual Career Series to **help equip young professionals with the tools to succeed.** The series included topical sessions, such as the inaugural "Nuclear Career Chat" that featured U.S. Department of State Foreign Affairs Officer Victoria Sanchez for a discussion on careers in nuclear non-proliferation. Future sessions will also include practical professional development opportunities to help attendees with topics such as writing their resume and cover letter; how to move between fields; and tips on picking a graduate program.

Strategies for Investing In Africa's Public Health Preparedness

UNA-NCA's African Affairs Committee partnered with the O'Neill Institute for National & Global Health Law at Georgetown University for a panel discussion concerning "Strategies for Investing in Africa's Public Health Preparedness." Public health challenges particularly in Africa, are a direct result of the continuing impact of non-communicable and communicable diseases adding to the daunting challenges of health systems strengthening facing the Continent. The forum discussed **the role that academia, private sector organizations and the non-governmental community** can play in building public health preparedness capacities in Africa. The forum also explored strategies to help invest in Africa's health workers, healthcare and social services infrastructure, logistics, surveillance and health information systems.

Careers in the United Nations

On June 26, 2019 UNA-NCA, in collaboration with The Fund for American Studies (TFAS), hosted a Careers in the UN Panel Discussion for **young professionals to learn about different career avenues** available in the United Nations network and its diverse set of agencies. Participants heard from Marco Fabian Sanchez, the Youth Engagement Coordinator for UNA-USA, and Liz Lizama, the Communications and Social Media Coordinator at the International Organization for Migration. The panel was moderated by Sultana Ali, the Communications Manager at the Pew Charitable Trusts and UNA-NCA Vice President for Communications.

The Future of Multilateral Peacebuilding



In partnership with USIP, The Stimson Center, and the Alliance for Peacebuilding, UNA-NCA's Peace & Security Committee hosted a timely discussion on **the future of the multilateral system and the potential for practical, innovative reform** with U.N. Undersecretary-General for Political and Peacebuilding Affairs Rosemary DiCarlo (*pictured right*) the highest-ranking American currently serving at the United Nations and the first woman to hold the position.



As a precursor to the U.N.'s 75th anniversary in 2020, this event considered how the U.N. has modernized its conflict prevention and management resources to address the changing nature of conflict; how reforms of the U.N.'s political and peacebuilding architecture have improved its effectiveness, as well as what steps are still needed; and what practical actions U.S. and international policymakers can take to support **more durable multilateral peacebuilding efforts**.



UNA-NCA was represented by its Executive Director, Paula Boland (*pictured above*), at the 68th UN Civil Society Conference in Salt Lake City, Utah on August 26-28. It was a historic event as it took place outside New York with over 5,000 attendees from over 130 countries and a record youth participation. The conference focused on Global Goal 11 of building sustainable, resilient and safe societies and offered a great variety of thematic sessions, networking opportunities and cultural events.

Eleanor Roosevelt Happy Hour

The UNA-NCA Human Rights Committee and Young Professionals Program hosted the annual Eleanor Roosevelt Happy Hour celebrating her birthday, the International Day of the Girl, the 74th Anniversary of the UN and the 71st anniversary of the Universal Declaration of Human Rights. UNA-NCA was honored to be **joined by Washington, DC's Delegate in Congress, Congresswoman Eleanor Homes Norton** (pictured left, second from left), who also delivered remarks. This was a great opportunity to meet members, volunteers, and staff from UNA-NCA, as well as other DC, Maryland, and Northern Virginia folks interested in hot topics in international affairs.

International Youth Peace Forum Conference

The Inaugural International Youth Peace Forum (IYPF) is an Annual Global Education Peacebuilding Conference that involved a diversity of university academic and student representatives, civil society and policy leaders in an open dialogue focused on best practice people-to-people exchanges, conflict prevention and resolution and peacebuilding priorities.



The conference convened in Washington, DC on August 12-16, 2019. Participants were involved in **diverse multicultural dialogue**, group discussions, site visits (including: UN Information Center, Embassy of the African Union to the U.S., National Museum of African American History and Culture, United States Institute of Peace, the Embassy of South Africa to the United States, and the U.S. Congress) in an interactive learning environment, leadership training and **knowledge transfer activities with people to people exchange**, conflict prevention and resolution, and peacebuilding program development experts.

Voices of Middle Eastern Youth

On July 24, 2019, UNA-NCA in partnership with New Story Leadership (NSL) and the Stimson Center presented a moderated discussion that **brought the diverse perspectives of Israeli and Palestinian youth who have first-hand experiences with the UN's work on the ground**. The audience was joined by eight delegates, half from Israel and the other half from Palestine, from the New Story Leadership program. These individuals spoke about their experiences of living within a historically unbalanced region that is filled with religious and ethnic conflict, yet these problems have not stopped them from maintaining such success within their native lands and abroad. As part of the New Story Leadership program, the delegates spent their summers on Capitol Hill working for various U.S. Representatives as well as leading their own "Projects for Change" in order to work towards internal peace building between Israel and Palestine.




