

GRADUATE FELLOWS PROGRAM

The mission of the Graduate Fellows Program (GFP) is to help Fellows develop an understanding of UN issues, policies, and organizations preparing for UN-related careers.

Hosted this past spring, this semester-long program provided 25 students from 11 countries, 10 states and 7 universities with multiple opportunities to discuss modern issues with experts across many relevant topics, all through a UN Lens. This included 13 in-person expert-led discussions, as well as mentoring opportunities, and career development sessions.

"As a medical anthropology student, the UNA-NCA Graduate Fellows Program helped me understand how diplomacy, funding, and politics shape global decisions around health, equity, and human rights. Through engaging seminars and meaningful dialogues, I gained critical insight into the role of representation and accountability in international development. 

 UNA-NCA collaborates with its parent organization, UNA-USA, as well as the Better World Campaign, to educate and advocate on behalf of a strong partnership between the United States and the United Nations. UNA-NCA serves as a constituent liaison to Members of Congress, offering resources on a number of related policies and practices that pertain to the UN's agenda. Advocacy engages with members in many ways including connecting

them with their Congressional and state legislature representatives, host

advocacy workshops, and produce original research.

In the lead-up to the pivotal 2024 U.S. Presidential elections, the Advocacy Committee hosted a coffee chat discussion on October 22, 2024, titled "The Importance of International Engagement in the 2024 Presidential Elections."

The event featured Mrs. Kathryn Kross of the Better World Campaign, who offered valuable insights into

the role of international institutions, particularly the United Nations, in shaping U.S. foreign policy discourse during the election cycle. Her remarks emphasized the enduring importance of global cooperation and the ways in which international engagement remains a vital consideration for American voters and policymakers alike.

ADVOCACY

In the spring of 2025, the Advocacy Committee spearheaded a robust series of Congressional meetings to champion the critical need for strong U.S. funding for the United Nations. These high-level discussions underscored the UN's pivotal role in addressing today's most urgent global challenges, including delivering life-saving humanitarian aid and maintaining peacekeeping operations, combating global health threats, and driving climate action. At every turn, we powerfully highlighted how sustained U.S. support for the UN directly advances international peace, security, and shared prosperity.

Meetings included two with Maryland representatives, April McClain Delaney and Jamie Raskin, and two Virgina representatives, Suhas Subramanyam and Gerry Connolly.


GLOBAL GOALS AT HOME



Global Goals at Home (GGH) is reimaging how we understand, measure, and create social impact.

Through the creation of a groundbreaking online dashboard, the Global Goals at Home program is cataloguing, localizing, and contextualizing progress towards achieving the SDGs across Maryland, Virginia, and Washington, D.C.

The SDGs offer an interconnected blueprint for sustainable and inclusive change.



Global Goals at Home partnered with Accenture's Data Science for Social Good team to track progress towards the UN's 17 Sustainable Development Goals (SDGs) across DC, Maryland, and Virginia.

The teams collaborated to create an automated, filterable, publicly accessible dataset that empowers local communities to track and report

progress towards regional sustainability goals while leveraging the GGH Localization Framework. This collaboration was announced at a Summit of the Future side event on Advancing the SDGs with GenAl in September 2024, cohosted by UNA-NCA partners, Accenture, Bay Area Global Health Alliance, Net Hope, and SID-US.

GLOBAL CLASSROOMS DC



Global Classrooms DC (GCDC) is UNA-NCA's flagship education program. It introduces students in grades 5–12 to international affairs and the work of the United Nations through Model UN simulations, original global education curriculum, and annual conferences. GCDC fosters skills in public speaking, negotiation, research, and writing, preparing students to become globally aware citizens.


This year GCDC held two conferences, its Winter Model UN Training Conference and their Spring Model UN Conference. The Winter Model UN Training Conference was hosted at the Pan American Health Organization (PAHO).

Designed for beginner and intermediate Model UN students in grades 5–12, the conference provided hands-on training in public speaking, resolution writing, and the rules of procedure. It helped students build confidence and skills before participating in more advanced Model UN simulations.

The Spring Model UN Conference is GCDC's culminating event of the year, held annually in the U.S. Department of State. The conference brought together 400 hundred students and educators from the DC metro area and beyond to simulate UN committees and debate pressing global issues. The conference enables students to apply key skills in a real-world setting, fostering global awareness and youth engagement.

The celebration marked the 76th anniversary of the Universal Declaration of Human Rights and the 79th anniversary of the United Nations. We were incredibly delighted to present awards to four outstanding individuals and one organization



who are working to improve human rights in their communities and around the world.

Overall the night provided wonderful remarks and insights from the honorees about their experiences including a moving speech from recipient Alexandria J. Maloney about significance of collaboration, education, and equality, alongside the imperative to hold human rights abusers accountable globally, to foster a more just and equitable world.

We thank all of our sponsors, our Human Rights Committee, and our staff for making this evening special. We congratulate all of our wonderful honorees and continue to celebrate their accomplishments together as a community.

LEAD AND ENGAGE



In May 2024, UNA-NCA President, Paula Boland attended the UN Civil Society Conference in Nairobi, Kenya (first one to take place in the continent of Africa) and other UNA chapter leaders and representatives from the World Federation of UN Associations joined her. The conference was an important platform for civil society to provide feedback for the Summit of the Future and Pact of the Future adopted in September 2025.

From January 28-31, 2025, UNA-NCA Board Member Kristen Hecht proudly participated in the Sixth International Conference, "For World Balance," in Havana, Cuba. This inspiring global gathering, centered on "Strengthening Multilateralism as an Indispensable Mechanism for Global Balance," brought together hundreds of international civil society leaders committed to advancing peace, security, human rights, and global cooperation.





Anne Simmons-Benton, Chair of Board of Directors attended Women20 South Africa (W20SA) from May 21-22, 2025. This year marked the tenth anniversary of the W20 which was founded by the G20 with the long term aim of reducing the gender employment gap by 25 percent by 2025. The event united leaders, change-makers, and visionaries to explore solutions to pressing challenges women face today through high level interventions, impactful panels and discussions, including outreach with rural, township and business women in agriculture.

The 79th session of the UN General Assembly (UNGA 79) held the Summit of the Future from September 22-23, 2024 and both President Paula Boland and Board Chair Anne Simmons-Benton were in attendance. It was an exciting week in New York City which involved a meeting with Senator Ben Cardin and side event focusing on Advancing the SDGs with GenAl, featuring several innovative projects, including our very own globalgoalsathome.org collaboration with Accenture's Data Science for Social Good team.

On October 11th 2024, UNA-NCA held an event focused on Human Rights Defenders (HRDs) and the Sustainable Development Goals (SDGs).

Professor Justin Hansford and Ms. Mary Lawlor led the conversation exploring the challenges facing HRDs around the world, with over 300 HRDs were killed in 28 countries in 2023 according to Front Line Defenders, and also the extraordinary stories of success. Mary Lawlor took up the mandate of United Nations Special Rapporteur

on the situation of human rights defenders on May 1st, 2020. In October, she presented her 4th Report on the topic of HRDs and the SDGs to the UN General Assembly in New York City.

Past annual reports have focused on youth HRDs, women HRDs in situations of conflict, HRDs working on the human rights of refugees, and HRD successes.


